Seat mechanism synchronously adjustable, can be locked via hand lever in 3 positions. Initial tension via hand lever in 12 weight settings adjustable.

Separate sliding seat plate, lockable via hand lever and return spring. Separate seat tilt adjustment via eccentric lever adjustable. Backrest frame made of plastic (PP), fixed in height and depth. Armrests with base made of diecast aluminium or glass fiber reinforced plastic (PA6) adjustable in height and in the clear width with clamping lever or with tool, support made of flat steel 30 x 10 mm.
